

Within the guarantee period, which varies depending on the product, we will either repair or replace the device free of charge in the case of defects that impair the function of the device. Products which have been damaged due to improper use or improper storage¹⁾ are excluded from the guarantee. Products which expire at the end of their normal life, in the course of normal use, are also excluded from the guarantee. Your guarantee period begins on the initial date of purchase. This does not affect your statutory guarantee rights.

Batteries that are not required for immediate use should be stored in their original packaging. Batteries should not come into direct contact with other metal objects or other batteries

²⁾ The guarantee period for the shelf life of non-rechargeable batteries only extends to the guaranteed storage period during which the product will still function. This period commences on the date of manufacture and ceases at the latest on the "best before" date, which is printed on the packaging and/or on the product.
